

# Hon. Timothy K. Lewis



Before entering private practice, Judge Lewis served on the U.S. Court of Appeals for the Third Circuit. He was serving on the U.S. District Court for the Western District of Pennsylvania when President George H. W. Bush elevated him to the Court of Appeals in 1992. At the time of both appointments he was the youngest federal judge in the United States. Before being appointed to the federal bench, Judge Lewis served as an Assistant U.S. Attorney for the Western District of Pennsylvania and as an Assistant District Attorney in Allegheny County, Pennsylvania.

As a federal judge, Judge Lewis tried, decided and authored opinions in all matters that came before the federal courts, particularly in the areas of employment disputes, class actions, intellectual property, and commercial and corporate disputes. Judge Lewis has developed a national and international ADR practice involving many of the world's leading corporations. Judge Lewis also provides strategic counseling and conducts moot courts in various federal appellate matters in circuit courts throughout the country. Judge Lewis also handles federal and state criminal cases and corporate investigations.

## Judge Timothy K. Lewis Experience:

As a former Federal Judge, I have presided over and authored opinions in too many complex contractual disputes to list. As an Arbitrator, I have likewise presided over many complex commercial contract disputes. A sampling includes:

- A Wellington Agreement dispute between the Owens Corning Trust and a major insurance provider concerning whether the Trust claims fell within "product/complete operations" coverage (exhausted), or "non-products" coverage (not yet exhausted), and involving factbased defenses as well as prior settlement, laches, accord and satisfaction, etc.
- A Wellington Agreement dispute concerning whether Schedule D required excess insurance to pay defense costs; whether the costs fell within aggregate policy limits; whether lowerlayers were exhausted, etc.

- Breach of contract claim between a major U.S. defense contractor and a German manufacturer of surface-to-air missiles concerning a Workshare Agreement for the development of short range air-to-air missiles.
- Commercial contract dispute concerning the supply and manufacture of FDU and ECU systems for aircraft engines.
- Contract dispute between an international helicopter engine sales and leasing company and a French manufacturer of low-end medium-power gas turbine turboshaft engines for helicopters.

- Breach of contract dispute between major providers of medical instruments, laboratory diagnostic solutions, imaging products and technology products and a hospital system concerning provision of technological and IT support services.
- Appeal of an arbitration decision between a major manufacturer of healthcare and medical products and a foreign multi-national healthcare company concerning patent infringement of glucose monitoring devices.
- Breach of contract dispute between two of the largest pharmaceutical companies in the United States concerning an over-the-counter joint venture.
- Contract dispute over royalties owed for a company's contribution to the "ThinPrep" system pursuant to a licensing agreement.

 Breach of contract dispute between an international organization that refers individuals to healthcare providers for state-of-the-art diagnostic and treatment procedures and a company that had developed a diagnostic contrasting agent concerning the licensing for use of the agent in clinical trials.

#### **Pro Bono:**

- Judge Lewis was one of four former federal appeals judges who took the unprecedented step of
  - filing an amicus brief on behalf of Delma Banks in the United States Supreme Court in 2003, in a case in which the court overturned the death penalty.
- During the fall of 2003, Judge Lewis chaired and moderated a series of national town meetings and congressional-style hearings called by Amnesty International on the subject of "Racial Profiling, Pre- and Post-9/11."
- In December 2002, Judge Lewis served as the U.S. representative on an international faculty of judges and mediators during a U.S. AID-sponsored Mediation Roundtable in the Republic of Croatia.
- In February 2008, Judge Lewis served as a Delegate to the U.S.- Russian Roundtable Conference on International Peace in Moscow, which was an outgrowth of the G-8 Summit, and delivered the opening statement on behalf of the U.S. Delegation.
- Judge Lewis is a co-chair of the National Committee on the Right to Counsel (with former Vice President Walter Mondale as honorary co-chair), a bipartisan committee established by the National Legal Aid and Defender Association and the Constitution Project to review the indigent defense system throughout the nation and create consensus recommendations for necessary reforms.
- Judge Lewis has filed many amicus briefs in the U.S. Supreme Court in cases ranging from the death penalty to bankruptcy matters to judicial ethics.
- In 2014, Judge Lewis advised Pennsylvania Governor Tom Wolf on the constitutionality of imposing a moratorium on the death penalty in Pennsylvania, which was adopted and implemented by the Governor.
- In 2016, Judge Lewis testified before Senate Democrats on the pending nomination of Judge Merrick Garland to the United States Supreme Court.
